Addendum

1. The Secretary-General has received notification of the resignation of Mr. Wolfgang Münch (Germany) from the membership of the Advisory Committee on Administrative and Budgetary Questions. Accordingly, the General Assembly will be required at its current session to appoint a person to fill the unexpired portion of the term of office of Mr. Münch, that is, until 31 December 1995.
